07.01.00 Chairman's Welcome

07.02.00 Public forum

07.02.01 No members of the public were present.

07.03.00 Acceptance of reasons for absence

07.05.00 Minutes of the previous meeting

07.06.00 Police update.

07.06.01 The police emailed their report for the period of the 11th June 2018 to 11th July 2018, which consisted of one crime. 01-02/07/18 A vintage tractor and Flail Mower were taken from a barn on Cliff Road.

07.08.01 It was decided to postpone the discussion on this item and put it on Septembers Agenda to give the new head time to settle in and for us to get more information on what help is most needed/sort after.

07.09.00 Village Hall Heating System

- 07.09.01 The Village Hall Heating System was constantly running due to it battling with the thermal heating panels on the roof. It was decided to let the thermal panels heat the Village Hall's water without the other system, only switching the other system on once a week to make sure the water system is heated to 65 degrees as per regulations. An engineer has inspected the system and explained the problem is with the compressor unit as it can't function properly as it is designed to, due to it being too large. As the compressor is 10 years old and over its service life we can leave it switched off in summer and then wait for it to make the system completely fail in winter when switched back on. Or we could replace the compressor with a more modern smaller unit which would also reduce the electric running costs. It is believed to cost somewhere between £6k & £8k to replace, a quote has been asked for but has not arrived at present.
- 07.09.02It was decided that we can't authorize the fitting of a new compressor until the total cost had
been confirmed. Considering this and due to the next meeting being in September and the
heating system needing to be fully operational before the colder weather. It was agreed that if
the quote was £6K it could be authorized as that amount had been already earmarked inSSg

reserves for that use.

07.10.00 Maintence Schedule for the village.

- 07.10.01 A parishioner had asked for the undergrowth on Castlehill under the trees next to the bend in the road to be cut back to help motorists gain visibility as it is particularly dangerous at present due to cars parked on the road and not being able to see if its clear ahead to overtake them. It was decided to task the handyman with cutting the undergrowth at that point to make the
- 07.10.02 road safer. Then ask him to cut the hedge on Castlehill next to Beck Street. After finishing surfacing the steps up to the line bank from Dycote Lane with road planings.
- 07.10.03 It was agreed to get the clerk to contact BDG to cut the bank on Castlehill as they have in the area they have done in the past as due to the dry weather the verges don't need doing so we will still be within budget and they should have the time available.

07.11.00 Do we need Pest Controllers at present?

- 07.11.01 Earlier this month there was regular reports of sightings of rats on the grass verge in front of the Village Hall's pond next to Beck Street. Over the last week or more they haven't been spotted there, so it was decided not to get pest controllers in at present. It was agreed that we would apply for the Litter grant given by NKDC again this year and then get a price and consider getting a new bin with a false bottom which contains a pest control box baited with a rod of poison which people and children could not access but the rats could, to go next to the seat in front of the pond.
- 07.11.02 The clerk was also asked to contact NKDC to see if they provide the relevant courses to be able to legally put poison down and get information on them.
