09.07.05	Ragwort Control A specific ragwort control herbicide had been bought but a parishioner had kindly pulled up all specimens on Castle Hill before it could be used. The spray would be kept till next year	
09.08.00 09.08.01	COUNTY/DISTRICT COUNCIL MATTERS LC reported that the she had gone through the Site Allocations Technical Document and that it suggests that, on average, settlements such as Welbourn might expect between 10 and 13 new homes over the next 20 years. It was agreed that this was entirely consistent with what had been happening over the previous decades. It was not clear whether the suggested allocation was in addition to the 30 already approved but not yet built, clarification is needed. She encouraged the Council and the Planning Group to respond the site allocations consultation.	RS/ Clerk

09.11.01	Village Hall. NTR.	_		
09.11.02	Highways, Footways and Drains. It had become known that Anglian Water are not notified about smaller developments and have no means of finding out in advance that extra facilities are required until the builder applies to connect to the mains. There were thus about 30 potential applications in train about which AWA had had not been formally informed. These figures did not include the extra internal facilities planned in Welbourn Hall. AWA had stated that the existing sewage treatment system could not cope with more than 10 new properties.			
09.11.03	<u>Village Matters</u> . The potholes at the bottom of Dycote Lane had still not been filled although work had been done in Moat Lane. The Chairman had taken action about the hedge overgrowing the footpath opposite Blackthorn Stables.

09.11.05	<u>Cluster Group</u> . The September meeting of the Cluster Group had been postponed till November when it was hoped to meet the new heads of our local policing team and to be briefed on how Councils were expected to respond to planning applications under the new rules.

09.11.07	Health Social and Welfare. It was queried whether the village should have defibrillator. It was agreed in principle that it should. JL would investigate and report.			
09.11.08	Allotments. SB sought permission to buy new trees to replace those which had died. This was agreed within the assigned budget limits.			
09.11.09	Castle Hill. Work continued on Castle Hill as planned.			
09.12.00 09.12.01	PLANNING The old Co-op The Council had written to NKDC highlighting the defects in the planning application for the old Co-op whilst welcoming the move to refurbish the historically important building and bring it into productive use. The application had failed to recognise that Mr and Mrs Brownlow live at the rear as owner occupiers and have rights of access through the yard and the application had, in Council's view, mis-stated the parking problems that would arise with two families in residence. Mr Brownlow confirmed his agreement with this approach and confirmed that his deeds gave him rights of access. LC agreed to take up the problem with the Planning Officer with a view to clarification of the issues.			
09.12.02	Welland Cottage The Council had written to NKDC highlighting the parking issue that would arise if the cottage were to be occupied in its intended new form stating that off street parking provision was essential and that the front railings are an important integral part of the character of Welland House. (Post meeting this application was withdrawn.)
